

Terms and Conditions for PTotR Team Facebook Group

- The membership fee is non-refundable, except in cases where the Group is no longer available or as otherwise specified in these Terms.

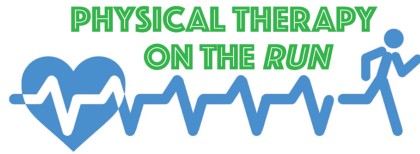
3. Group Content

6. Payment and Refund Policy

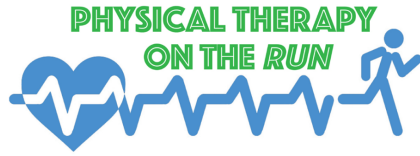
- The membership fee is recurring and will be charged to your chosen payment method monthly.
